

## Life-Saving Rules

The *Life-Saving Rules* of EVE are deemed to be safety-critical and there is zero tolerance for violation. Violating the *Rules* would mostly cause serious consequences with high probability such as serious injury, fatality, fire and explosion, etc. Anyone shall be aware and comply with 100% the *Rules* in the workplace:

MUST NOT take lighters into the workshop or warehouse. MUST NOT smoke outside designated areas.

MUST NOT start any hot work in hazardous flammable and combustible areas without authorization.

MUST NOT override any fire protection facilities without authorization.

MUST NOT work at height without authorization, or NOT work without fall protection equipment.

MUST NOT enter a confined space without authorization or test and monitoring of the atmosphere.

MUST NOT conduct special operations such as electrical work, mechanical lifting driving, welding, etc. without qualifications and skills or being competent.

MUST NOT disable, bypass, override, or destroy Safety Critical Devices. (E.g. Light curtain, interlock, stopper, gas alarm. The protection devices for over temperature, overpressure, over-voltage, and timer. Fire extinguisher equipment, monitoring and early warning devices, emergency shutoff valves and ventilations, etc.)

MUST NOT produce, store, or test batteries in places where DO NOT meet the safety requirements.

MUST NOT drive or work under the influence of alcohol or drugs.

MUST NOT start maintenance work before hazardous energy resources have been isolated, locked, and tagged.



MUST NOT position yourself in a moving object of the equipment. MUST keep yourself and others out of the Line of Fire.

Safety is the cornerstone of sustainable development. It's the core competitiveness of lithium battery corporations.

The disciplinary action for violating *Life Saving Rules* is as follows:

EVE commits: those who correct and report unsafe actions, potential hazards, risks, or near-misses, will be recognized and encouraged. No penalty will be issued.
